**BID NOTICE UNDER NATIONAL COMPETITIVE BIDDING FOR
PROCUREMENT OF GLOBAL IMAGING SYSTEM EQUIPMENT (GIS)**

The Government of the Republic of Uganda through The Ministry of Agriculture, Animal Industry and Fisheries (MAAIF) has received from the World Bank towards the cost of the Regional Pastoral Livelihoods Resilience Project, and intends to apply part of the proceeds for the Procurement of Global Imaging System Equipment.
2. The Entity invites your sealed bid for the supply of the above equipment
3. Bidding will be conducted in accordance with the National Competitive Bidding (NCB) method contained in the Guidelines for Procurement of Goods, Works and Non-Consulting services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from 8:00am – 5:00pm (Local Time).

The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 8(b) and upon payment of a non-refundable fee of **One hundred Thousand Shillings (Ugx.100, 000)**. The method of payment will be through Banks authorized to receive non-taxable revenue.
6. Bids must be delivered to the address below at 8(c) at or before 10th October 2017 at 11:00am (Local Time): All bids must be accompanied by a bid security of Ugx.1500,000/=. Bid securities must be valid until 7th March 2018. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at 10th October 2017
