Bidding will be conducted through Open National Competitive bidding using a Request for Quotations (RFQ) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" September 2023 ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.

- 5. The bidding document in English may be picked by interested eligible Bidders upon the submission of a written application. The document will be sent/issued by both email and in hard copy.
- 6. Bids must be delivered to the address below on or before **30**th **April 2025**; **11:00am local time**. Electronic Bidding will not be permitted. Late Bids will be rejected. The Bid envelope shall be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, at the address below **30**th **April 2025**; **11:30am**; **local time** at **the UCSATP Offices Plot 78**, **Buganda Road Wandegeya**.

- 7. All Bids must be accompanied by a Bid Securing Declaration.
