2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open domestic bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.

The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 9(a) and upon payment of a non-refundable fee of **UGX 50,000/= (Uganda Shillings Fifty Thousand only).** The method of payment will be through Banks authorised to receive non-taxable revenue.
